Alabama in Square No. twenty three (23) commencing at  
the intersection of Sibley and fourth Streets and running South  
on fourth Street to Adams Street 9.48 Chains thence West 3.16 Chains  
thence north to Sibley Street 9.48 Chains thence East on Sibley  
Street to fourth Street the place of beginning 3.16 Chains

Church and burial Place
